There are all together 16 gambling operators and State owned Joint Stock Company "Latvijas Loto" (state run lotteries – land-based and on-line).

There have been issued:

9 land-based gambling operation licenses

5 betting point operation licenses

13 on-line gambling operation licenses

Due to COVID-19 pandemic, by the decision of the Government of the Republic of Latvia gambling companies were prohibited to carry out all <u>land-based gambling</u> activities – casino, gaming halls and betting points were closed **on 2022** from January 1 till February 28.
