## Gambling market of Latvia on 2023

There are all together 20 gambling operators and State owned Joint Stock Company „Latvijas Loto" (state run lotteries - land-based and on-line).
There have been issued:
8 land-based gambling operation licenses
4 betting point operation licenses
18 on-line gambling operation licenses
On December 31, 2023 there were 31692 persons included in Self-excluded persons register. During the Year 2023, number of included persons increases on 5942 persons.
