There have been issued:
10 land-based gambling operation licenses
5 betting point operation licenses
13 on-line gambling operation licenses
Due to COVID-19 pandemic, by the decision of the Government of the Republic of Latvia gambling companies are prohibited to carry out all land-based gambling activities - casino, gaming halls and betting points were closed:

## On 2020

- From March 22 until June 9 and
- from November 9 until December 31 (February 7, 2021);

Remote gambling activities were closed from April 8 until June 9.
On 2021
Gambling companies are prohibited to carry out all land-based gambling activities casino, gaming halls and betting points are closed:

- From January 1 until now.
