## Lotteries and Gambling market of Latvia on 2020, 6 months

There are all together 15 gambling operators and State owned Joint Stock Company „Latvijas Loto" (state run lotteries).
There have been issued:
10 land-based gambling operation licenses
5 betting point operation licenses
11 on-line gambling operation licenses
Due to COVID-19 pandemic, there have been closed gaming halls, betting points and casinos on March 22 till June 9, to protect players from no responsible pay-outs online gambling sites have been closed on April 8 till June 9.

Self-excluded persons register starts on January 1, 2020. On July 30, 2020, there are $\mathbf{8 5 4 5}$ persons included.
