6 months 2014 there were issued by the Inspection:

- 135 lottery permissions (for lotteries prize fund whereof is larger than 720 EUR;
- 332 lottery confirmations (for lotteries prize fund whereof is smaller than 720 EUR).

Total prize fund being subject to a state fee shall be 836 550 EUR and the state fee collected constitutes 203 592 EUR.

Income from the said fee shall be used for implementation of design of the National Library of Latvia pursuant to provisions of the Law on Lotteries of Goods and Services.
