**Sales promotional lotteries**

On 2015 there were issued by the Inspection:

- 269 lottery permissions (for lotteries prize fund whereof is larger than 720 EUR;
- 646 lottery confirmations (for lotteries prize fund whereof is smaller than 720 EUR).

Total prize fund being subject to a state fee shall be **1 423 744 EUR** and the state fee collected constitutes **357 585 EUR**.
